#### **POSITION OVERVIEW:**

Children's Health Fund (CHF) is a nonprofit organization that supports a National Network of healthcare programs for medically underserved children and families. We are seeking a development professional with excellent writing skills and a high attention to detail to play an integral role in Children's Health Fund's institutional giving team.

The part-time Institutional Giving Associate will support Children's Health Fund's efforts to cultivate, build and maintain a pipeline of major institutional gifts to meet growing programmatic needs. The Institutional Giving team manages a portfolio of over \$9 million of corporate, foundation and government grants. Duties include: 1) drafting and proofing letters of inquiry, proposals, reports, acknowledgements, and other correspondence as necessary; (2) donor identification, cultivation and stewardship; (3) database management of calendars and deliverables; and (4) donor volunteer management support as needed.

The Institutional Giving Associate is expected to develop an understanding of the entire organization, serve as a partner with program staff in the development of funding proposals for new initiatives, and foster effective teamwork across departments. The Institutional Giving Associate reports to the Senior Manager, Institutional Giving.
